## SUBJECT: FEE PAYMENT IN SECOND SEMESTER 2021/2022 ACADEMIC YEAR All students are reminded as follows:

- a) The Second Semester of 2021/2022 Academic Year commenced on Monday, 24<sup>th</sup> January 2022 for First Year students and Monday, 28<sup>th</sup> February 2022 for continuing students. Students were informed of Second Semester (2021/2022 Academic Year) Timelines via communication referenced as follows:
  - i) First Year Students- Memo (KarU/Rg, AA/1/Vol.8) dated 28th January 2022 and;
  - ii) Continuing students-Memo (KarU/Rg.AA/1/Vol.8) dated 23<sup>rd</sup> February 2022.
- b) In the referenced communications:
  - i) First Year Students were required to complete payment of Fees for the Second Semester 2021/2022 Academic Year by Friday, 18<sup>th</sup> March 2022.
  - ii) Continuing students were required to Complete payment of Fees for the Second Semester 2021/2022 Academic Year by Friday, 22<sup>nd</sup> April 2022.
- c) Fees Payment Policy (Clause 5.5) stipulates, but is not limited to the following:
  - i) Students will pay all fees on the day of admission and registration.
  - ii) Students with financial challenges may be allowed to pay in two installments in the following manner:
    - 60% and above on admission and registration
    - The balance of 40% shall be cleared by the 40<sup>th</sup> day after the beginning of the semester
  - iii) On the forty-first (41<sup>st</sup>) day after the beginning of the semester the University will place an encumbrance on the student account that includes but is not limited to "deregistered for that semester".
  - iv) The repercussion includes seeking re-admission after:
    - All outstanding fees balance is cleared and fees for the semester.
    - A reinstatement fee (penalty fee) equivalent to the application fee for the programme will be charged.

NB: Therefore, all students are further reminded to adhere to the regulation or defer studies to the next Academic Year (2022/2023).
